

#### **Executive Summary**

Summary - Principle 1 - 3

Having a young team of personnel assigned responsibilities for certification, Linddale group of companies has established a system of documentation which includes required policies, operating



procedures, document on internal audits and the reviewing of audit results. Information on the organisation can be made accessible from the internet should the management decided to have a company's website, to bear out transparency. We detected their list of stakeholders were not complete (OFI) missing a nearby school. They demonstrate general compliance to legal requirements, having ready communication with the authorities such as the Manpower Department. Aspiring to employ modern technology in activities requiring aerial surveillance, the management may need to establish a system on adopting improvement practices in line with new technology. We found no issue on land as the properties were acquired through Sales and Purchase agreement and are titled.

# Summary - Principle 4 (People)

Social impacts are identified, and plans are implemented to mitigate the negative impacts and promote the positive ones. A system for dealing with complaints and grievances is established and documented. The only village community registered in the stakeholder list is Kampung Paris 2. The management responded well to request of assistance from local communities.

We found a sharp broken stump left unattended in the bushes in the vicinity of the labour line in Division 1 that impose risk to injury to personnel moving about in the area, that we see as ineffective implementation to their safety policy (NC). Their HIRARC missed documenting the operation of a quarry found in the estate (NC). We also noted that some of their safety committee members were not recorded in their minute of meeting (OFI) and report of an accident was not brought up in their meeting (NC).

Condition of employment are satisfactory to the workers that includes good housing facilities and fair wages. Engaging contractors to carry out work in the nursery, we found the need for the management to ensure that the employees of the contractor are paid according to their agreement with their employer (OFI). Training is an ongoing activity, carried out according to their training programme and following their operating procedures.

# Summary - Principle 5 (Planet)

There is guided plan to address issues on environmental concerns including segregation of domestic wastes before disposal to landfills and having environment as an agenda during meetings. We found the containment around the fuel skid tank was not well constructed (NC) and to be rectified. The usage of fuel is monitored but limited to own consumption only. There is a need for the data of fuel usage to be acquired from the contractor to provide an accurate estimation of GHG emission (OFI).

Scheduled wastes are taken for disposals by registered collector. We noted facility for throwing of wastes in recycled bins in the housing compounds to implement recycling and segregation of wastes before final disposals.

The management established a water management plan to maintain the quality and availability of natural water resources (surface and ground water). This includes monitoring plans, record on water usage and treatment.



HBV Assessment was carried out using HCVF Toolkit for Malaysia and a Sabah Wildlife Department. Zero burning is being practiced.

## Summary - Principle 6 (Profit)

An Oil Palm Agricultural Policy is available but may need reviewing to incorporate replanting activities and other new practices in line with new technologies available (OFI).

Fields are divided into blocks and are indicated in the field. A budget is established with records on monitoring achievement of the goals and objectives. Contractors are made to understand MSPO requirements through briefing. The management provided evidence of agreed contracts with the contractor.

In conclusion, the management system of Linddale Group of Companies in general is effective and fulfils the requirements of the standards of MSPO.
